Nolan says: I have repeated those prayers night and morning, it's now fifty-five years. a day, he had read of the us, but only within the sort of a prayer to uphold its leaders; the U.S. Navy had neglected to stay this book from him. this is often the supreme irony of the story. Nolan asks him to possess them bury him within the sea and have a gravestone placed in memory of him at Fort Adams, Mississippi, or at New Orleans . When he dies later that day, he's found to possess drafted a suitably patriotic epitaph for himself: In memory of PHILIP NOLAN, Lieutenant within the Army of the us .
