I used to climb 20 coconut trees every morning, noon and evening, mount over top, sit on one of the palms and tap the juice. One evening after sunset, while atop the sanggutan, I saw a glow, a distant glow. I muttered to myself: Someday, Ill find out what causes that glow. I equated that statement to my goals in life. I did find out what caused the distant glow. Other distant glows appeared and I reached most of them with hard work and having a dream. When the owners of a private school offered me an opportunity to go to their school free of tuition, provided that I maintained the first place standing in the class honor roll, I went to high school, starting at age 20. To help shoulder the other costs of going to high school in the city, I paid my room and board with service: scrubbing and polishing the floor, fetching water from an artesian well and gathering firewood every weekend for the landlord family. With all the hardship, I maintained the tuition-free deal and graduated from high school as class valedictorian.
